BOARD MEMBER VOLUNTEERS. Reminder there will be elections in 2022. We need YOU to volunteer. Without volunteers we will, by law, have to hire a management company at the minimal cost of **\$175 extra per household per year!** This is not a hard job and we need more help. Talk to the board members to find out what it entails. It's only a couple hours of your time each month.

Retention Pond Drains. We have responsible for the pipes from Turtle Crossing to S Captain's Pointe Cir. The county is responsible for the drains & under the road at S. Captain's Pointe Cir. Then us again from the drain on S Captain's Pointe Cir to the retention pond. From the north retention pond to N. Captains Pointe Cir. The county again has the drains and under the road. We then have the pipe from N Captains Pointe Cir to the Shores property. We MUST have reserves to fix these pipes. Money will be needed if any collapse like the one on the south side of the retention pond did a couple of years ago.
